## Conditions and Authorizations:

D. Authorized to take up to 25 common mergansers per year in 2015, 2016, and 2017 as part of a comprehensive action plan to address swimmer's itch on Higgins Lake in Roscommon County Michigan.

Authorized to destroy up to 25 common merganser nests and all eggs therein per year in 2015, 2016, and 2017.

Lethal take is not to be the primary means of control. Active hazing, harassment or other non-lethal techniques must continue in conjunction with any lethal take of migratory birds.

Permittee will apply for a separate MI DNR permit for harassment and/or non lethal and lethal take of mergansers.

Permittee will be required to conduct surveys and bird counts each year to assess trends in merganser populations and will report findings in required annual reports.

Permittee will conclude any harassment or shooting activity before broods are present on the lake each year; harassment and shooting will conclude by May 22nd each year. Only adult birds will be taken during the spring migration period and prior to hatching. No juvenile or flightless birds will be taken.

All persons carrying out lethal take/shooting activity will receive formal training on species identification so only common merganers will be taken. No red-breasted mergansers will be taken.

This federal permit is not a special hunting permit for waterfowl or mergansers in Michigan; this permit is issued only to address the problem of swimmer's itch on Higgins Lake in Michigan. Birds taken under the authority of this federal permit will be transferred to Curtis Blankespoor's federal scientific collecting permit for research into swimmer's itch.

- H. You and any subpermittees must comply with the attached Standard Conditions for Special Purpose Miscellaneous Permits. These standard conditions are a continuation of your permit conditions and must remain with your permit.
- I. Amended 03/11/2016: Amended to clarify the location of authorized permit activity on Higgins Lake in Michigan. Per formal letter from The Lyon Township Board dated February 18, 2016, Lyon Township does not support federal permit MB56627B. This federal permit amendment restricts all permit activity to Gerrish Township only. No permit activity will occur within the political boundaries of Lyon

Amended to also clarify the chain of custody of common mergansers taken under this federal permit. All mergansers lethally taken will be turned over to MI DNR wildlife biologist, Mark Boersen. Gerrish Township/Northpoint Fisheries must contact Mr. Boersen and pre-arrange meetings to deliver merganser carcasses. Mr. Boersen (or another MI DNR designee) will identify the birds and notify SICON that they are available for pick up.

- < Amended 3/20/2017: Amended to clarify that nest/egg destruction is for natural nests only and not for artificial nest boxes. The intent of his permit was not to allow placement of nest boxes to attract more common mergansers to Higgins Lake.
