

Dear HLPOA Member,

The HLPOA Board is in full support of the proposed sewer system for Higgins Lake. Multiple lake studies completed over decades, as well as scientists who have studied our lake, have concluded a sewer system at Higgins Lake must be a top priority if we hope to maintain a healthy lake.

There is a small group promoting a petition to stall and potentially kill the sewer development. Fortunately, a petition process is now available for those of us who know a new sewer is essential. Copies of the petitions are attached. One is available for each township. Any property owner in the proposed sewer district is eligible to complete and submit this petition.

Here is what you can do. Print your appropriate petition, Gerrish or Lyon, and follow the directions on it. In order for the petition to be counted it must be signed by all those whose names are on the property. Please return the signed document to your township as soon as possible. **Petitions must either be hand delivered or sent via regular US mail! Faxes and electronic copies will NOT be accepted.**
