Aquatic Invasive Species (AIS) Data Collection at Higgins Lake Boat Accesses

Higgins Lake Property Owners Association (HLPOA) and Higgins Lake Foundation (HLF) work with the Department of Natural Resources (DNR) to combat the aquatic invasive species (AIS) that already exist in Higgins Lake and to reduce the risk of additional AIS entering the lake. The existing AIS are Eurasian Water Milfoil (EWM), starry stonewort (SSW) and zebra and quagga mussels. The DNR treat their three boat accesses with chemicals where needed to combat EWM and with Diver Assisted Suction Harvest (DASH) boat harvesting to control SSW. (There is no known treatment for zebra and quagga mussels.) In addition, they use signs and advertising programs such as "Clean, Drain and Dry" to make the public aware of AIS risks. They also provide cleaning stations at the accesses for the use of boat operators. The DNR makes only a limited effort to inspect boats for AIS at its thousand plus accesses around the state. Typically, their two conservation officers in Roscommon County allocate two hours a week to AIS inspections during the summer.

Higgins Lake Foundation takes on the extensive (and expensive) role of combatting EWM and SSW in the open waters of Higgins Lake with their DASH boat harvesting, now in its twelfth year. So far, this effort has proven adequate to keep EWM and SSW in check based on their annual harvest reports. In addition, this year their consultant, Dr. Luttenton, added monthly inspections for new AIS at the three DNR accesses as well as the other four most actives boat access around the lake (Maplehurst Avenue, Kelly Beach, Townline Road and Gerrish Marina). Early detection of new AIS will help with control or possible eradication.

Fall 2024

Since 2022, HLF and HLPOA worked together on interviews of boat operators at the DNR accesses and data collection involving all seven accesses mentioned above. The primary purpose of the interviews is to determine the relative risk of new AIS entry at the accesses based on the number of non-Higgins Lake boats arriving with visible weeds. From this work in 2023, we determined that 84% of the Higgins Lake risk is at the South State Park. As a result, the 2024 focus has been on the South State Park with interviews by HLF student workers. Collection of data on visible weeds on trailers after launch has also continued. This provides a comparison of relative usage between the accesses and a check of data consistency from previous years.

The interviews of operators and inspection of boats for visible aquatic weeds at the South State Park by the HLF students proved to be very effective this summer. Higgins Lake Foundation student employees, Tyler Cane and Megan Houserman, worked at the South State Park boat wash. The DNR provided a small workstation at the entry to the boat washes where the interviews and inspections took place. During the months of June/July, 394 boat operators were interviewed. About one of eight boats arrive with visible weeds, 13.7%. The boat operators were requested to wash or to allow the HLF students to wash their boats. Over 80% of the boat operators complied. Of the nine non-Higgins Lake boats that arrived with weeds, eight were washed which significantly reduced the 84% risk of new AIS entry while the HLF students were present.

In August thru Labor Day weekend, another 457 boat operators were interviewed and there was a surprisingly large reduction in the boats arriving with visible weeds, 4.2% versus the 13.7% in June and July. And only 1 of the 138 visiting boats arrived with weeds. Many of the boats that use the South State Park access are repeat users and the persistent weekly inspections by the HLF students seems to have improved the focus of operators on washing their boats. The HLF students worked 9:30 AM to 12:30 PM shifts on most of the busy Saturday and Sunday mornings. HLF plans to do even more next year by adding hours and possibly some additional shifts on holiday weekends. Let's hope that the improved focus on boat washing continues in 2025!

Higgins Lake Swimmer's Itch Organization's (HLSIO) year-end update

HLSIO had our trapping and relocation program reinstated after a two-year absence. We were able to take the only Common Merganser brood off the lake on June 20. Coupled with having a very low snail infection rate due to our program's past success, we saw a minimal uptick in Swimmer's Itch (SI) cases this summer.

Swimmer's Itch Solutions (SIS) published a peer reviewed paper this year which chronicles the success of their trapping and relocation of common merganser ducks as a solid solution for controlling SI on inland lakes.

HLSIO continued our water research study giving us even more data to analyze to tell us about SI on Higgins Lake and to better control SI in the future.

In addition, we did more research on the amount of time it takes parasites that infect ducklings to become viable. Now we have an even more accurate idea of how soon merganser broods need to be removed from the lake. This is extremely critical in keeping SI cases low. We anticipate another peer reviewed paper to be published on this subject matter soon. In August, HLSIO held their summer fundraiser dinner once again at Witt's barn, catered by Fred's of Roscommon. As in the past, everyone seemed to enjoy themselves. Dr Blankespoor of SIS discussed their relocation paper and answered questions for the attendees. Once again, the Higgins Lake community demonstrated their generosity in making the fundraiser a success.

Although it may never be possible to prevent any cases of SI on Higgins Lake, HLSIO continues to work at keeping them to a minimum.



Fall 2024 Macro-Invertebrate Survey in the Cut River and Big Creek

This fall the macroinvertebrate sampling team once again surveyed Big Creek and Cut River for all types of macroinvertebrates (insects, spiders, crustaceans, mollusca, worms) and performed a habitat assessment of each stream. The team followed sampling and processing protocols provided by the Michigan Clean Water Corps (MiCorps) and the Muskegon River Watershed Assembly.

This is the fourth year of sampling headed by Melanie Brown. The Cut River had a large drop in water quality rating in 2024 compared to previous years due to the low abundance of macroinvertebrates in the samples processed. Green filamentous algae, that was first noticed a couple years ago, is now covering the Cut River bottom throughout the sampling location in the river, which may be altering the habitat that supports macroinvertebrates. Big Creek appears to be holding fairly steady with more than half the years in the good and very good level of water quality. Testing for Oak Wilt

The deadly fungal disease, Oak Wilt, affecting oak trees is difficult to control. It is imperative to avoid pruning oaks between April and July and to immediately seal wounds during that time to prevent beetle access to these trees. Shared roots of infected trees can also infect healthy trees. It is now possible to confirm Oak Wilt using leaf samples. You can submit fresh and recently fallen leaves for accurate diagnosis. A trained arborist can then determine next steps to stop the spread of Oak Wilt. Infected wood should be burned buried, chipped on-site, or tarped for a year.
