# Health of Higgins Lake by Jim Ostling, Gerrish Township Trustee

The newly elected Gerrish Township Board is in place and working on the review of existing policy and procedures that affect the residents of the Township. We feel it is important that the business of local government be efficient, consistent, and accessible to its residents. Procedures without approved policy are being reviewed and appropriately amended or in some cases simply created. This will leave future Boards a firm foundation to conduct the business of the Township.

Last summer, as I contemplated running for an open trustee position, I watched and listened to issues within our government as well as those that surround a potential sewer discussion, I began to make notes about how I might be able to help. One of those notes was to address the Health of Higgins Lake from an overall new perspective. I have been gathering material, talking with residents to better understand their concerns, and assembling those thoughts and ideas into a document that can be shared. Since being elected, I have been working with the new Board to present various ideas and ask for its support.

As a product of that work, we now have the "bones" of a new fresh approach, as well as the support of the Township Board - Health of Higgins Initiative. While this project is still in its initial development, we have agreed upon the establishment of a Steering Committee and a series of sub-committees to address many facets of the impactors to the lake and its ongoing health.

Our next major step will be to solicit applications from those that want to be a part of the solution to the long-running concern over the health of our lake. The position descriptions are posted on the Gerrish website, and we will be formally accepting those applications for at least 30 days after our February Board Meeting.

It is our desire to assemble a team that will take a bi-partisan approach to the perceived problem of the deterioration of the quality of Higgins Lake. This will need the involvement of many people and organizations around the lake with a sincere interest in finding solutions that will assure protections for the Lake for generations to come.

### **Higgins Lake Winter Weather Information 1963-2005**

This weather information is from the personal observation of Mrs. Gladys Chinn, who was a full-time resident at the lake from 1963 until her passing in January 2005 at the age 96. Mrs. Chinn owned property on the lake since 1929 and was an unofficial historian of Higgins Lake. She charted weather and water conditions with such accuracy that the National Weather Service consulted with her many times to verify their records.

If you use private well water in the State of Michigan, it is your responsibility to test and maintain your well and the surrounding area. Michigan Department of Health and Human Services recommends testing your water's taste, color, or odor. Every year test for coliform bacteria, *E.coli*, copper, and lead. ## **Measuring Flow Rate in The Cut River**



Teams of volunteers are measuring the flow rate in cubic feet per second for The Cut River at a fixed location approximately 100' below the Roscommon County Road 100 river crossing.
